# **Business:**

- 1. Discuss, Consider and Necessary action on Minutes from February 20th.
  - a) Director Paulsgrove moved to accept the minutes from February 20<sup>th</sup>. Motion was seconded by Director Alicia. Motion Carried 6-0.
- 2. Hanging Basket Update/Sign Update.
  - a) Discussion Only. All of the hanging baskets have been hung and all 10 pots have been planted.
- 3. Discuss, Consider and take Necessary actition on resignation of Director Perez.
  - a) Director Cowley moved to accept Director Perez's resignation. Motion was seconded by Director Carlsberg. Motion Carried 6-0.
- 4. Discuss, Consider and take Necessary on board member applicants.
  - a) Discussion Only. Goliad Main Street Board will invite Peggy Cowey and Mindy Sullivan to the next 2 meetings and events so they can get a better understanding of the Main

Street Program. At the next meeting each board member will come back with 2 nominations.

- 5. Discuss, Consider and take Necessary action on having a "Hotter Than Heck" Blacksmithing competition in summer 2018.
  - a) Director Cowley discussed having a blacksmithing competition in downtown Goliad. Eric Scott is the President of the Goliad Forge. Director Carlsberg moved to invite Eric Scott with the Goliad Forge to the next meeting and discuss what they would need from Goliad Main Street. Motion was seconded by Director Urban. Motion Carried 6-0.
- 6. Discuss, Consider and take Necessary action on Tejano History Conference in May 2019.
  - a) Discussion Only. Director Cowley discussed it could be 2 nights, start with Friday night welcome in downtown from the Judge, Mayor, and Amigos. This will be followed by other events downtown. No action was made.
